The well site was inspected. No well testing was taking place at the time of inspection. No well testing equipment was deployed on site.

Groundwater quality monitoring boreholes on the East and West boundaries of the site were inspected. The boreholes were locked shut and are located within concrete rings with a lidded cover. It was reported that borehole levels are dipped by the HSE Manager on a weekly basis and that groundwater samples are taken by contractor.

The open section of the perimeter containment ditch on the North and West sides of the site was inspected. The ditch contained clear water of approximately 250mm depth.

The orange coloured 24 cubic metre capacity surface water tank at the North East corner of the site was inspected and found to be empty. It was reported that the tank is not currently in use. The tank is unbunded and is located outside of site containment area and is therefore suitable for storage of surface water run off only.

The well cellar was inspected. The cellar has been enclosed within in a roofed steel cage to improve security. The well site has an outer security fence, plus an inner security fence topped with razor wire. It was reported that there is currently a 24hr security guard presence on site.

The following equipment was present on site and was inspected:

Green potable water tank.

Blue 1200 litre banded diesel bowser.

Yellow 3000 litre banded diesel tank serving electricity generator.

SDMO electricity generator located in white acoustic enclosure.

Black 107 litre banded mobile fuel unit.

Blue cage containing water pump and plastic pipe connectors.

Washroom/toilet cabin draining to an above ground sealed tank.

Canteen cabin with sink draining to above ground sealed tank.

Office cabin.

Drying room cabin

Self contained security cabin.

Spill kit container.

1 open skip of non-hazardous general waste.

2 open skips of drill spoil from groundwater monitoring borehole drilling.
