The objective of the audit was to check compliance with management system procedures relating to sampling, testing, characterisation, and removal of wastes produced on site, to inspect records relating to waste duty of care, and to inspect records relating to the drilling operation for assessment against the requirements of the WNB-1 well WR11 notification.

Documents were inspected in electronic form at the Rathlin Energy (UK) Ltd Beverley office, and also remotely via a Dropbox.

Audit of management system procedures and records

Records in relation to waste drilling muds and cuttings, wood, excess cement, containment ditch water, hydraulic oil, and scrap metal removed from site were inspected. Waste duty of care paperwork, and the required completed waste sampling records (document reference RE-05-FO-062) and waste classification records (document reference RE-05-FO-061) were present. The wastes had been assigned appropriate EWC (European Waste Classification) codes and the destination waste management sites were confirmed as authorised to accept the wastes.

The MiSwaco mud engineer's daily mud report no. 38 for WNB-1 from date 06/11/2020 was inspected. The report records daily and cumulative mud additions. All mud additions recorded were additives approved under the Environmental Permit.

The drilling mud spreadsheet 'Mud tracking Salt Sat v1' was inspected. The spreadsheet is used to record drilling mud additive additions and mud removals so the potential build-up of properties within the mud that could exceed hazardous waste criteria can be identified. All potential properties were found to be either not present or well below hazardous waste thresholds.

Inspection of records relating to drilling operations

Daily operations reports for drilling operations were inspected and assessed against the requirements of the WR11 notification for the WNB-1 well. The aspects inspected were compliant.
