11:05 hrs on site. Very strong smell of gas/H<sub>2</sub>S in car park on the North boundary of the site adjacent to Flare Industries CEB 4500 gas flare. Smell reported to security 11:15 hrs. Met redacted on site and reported gas smell. Gas levels around flare immediately monitored with a personal gas alarm by redacted and found to be normal for CH<sub>4</sub>, O<sub>2</sub> and H<sub>2</sub>S. Gas levels monitored between 5 and 10 minutes after initial report to security. No gas alarms triggered.

It was reported that the flare sterile area is a 5m radius. It is necessary for operators to enter the sterile area to access the flare adjustment controls at the base of the unit.

The inner access walkway along the North side of the site is at the edge of/within the flare 5m sterile area and during site inspection it was barriered off to prevent use by security guards for the duration of flaring.

Flare operated for a period of approximately 10 seconds at 12:45 hrs. No visible flame. Heat haze present.

Gas flow to the flare is calculated using data from differential pressure and temperature monitoring on the separator. A copy of the differential pressure calibration chart ref: 'TX11-25 at 10:30am 28-07-14 ' was taken.
