Perimeter containment ditch:

The open section of the sealed perimeter containment ditch was inspected. Three small dead mammals were found to be present in the ditch and were removed and photographed. The mammals were subsequently identified by an Environment Agency ecologist as two mice and a vole. None of the mammals photographed were protected species.

The perimeter containment ditch is lined with HDPE which is slippery when wet. The operator has placed netting at five points along the open section of ditch in order to give any animals that fall in a better chance of climbing out.

The operator is carrying out vermin control on site using rodenticide in bait boxes and that is believed to be contributing to the numbers of small dead mammals found in the open section of containment ditch.

Water in the sealed perimeter containment ditch is emptied by tanker for off site disposal and is not discharged to surrounding watercourses.
